

Here is the language that will appear on your ballot:

Amendment 3

Do you want to amend the Missouri Constitution to:

- establish a right to make decisions about reproductive health care, including abortion and contraceptives, with any governmental interference of that right presumed invalid;
- remove Missouri's ban on abortion;
- allow regulation of reproductive health care to improve or maintain the health of the patient;
- require the government not to discriminate, in government programs, funding, and other activities, against persons providing or obtaining reproductive health care; and
- allow abortion to be restricted or banned after Fetal Viability except to protect the life or health of the woman?

State governmental entities estimate no costs or savings, but unknown impact. Local governmental entities estimate costs of at least \$51,000 annually in reduced tax revenues. Opponents estimate a potentially significant loss to state revenue.

Amendment 3 claims to support Women's Rights, but does it really?

At first glance, the carefully crafted language you will see on your ballot appears to support a woman's right to make decisions about her own reproductive health.

This might include things like prenatal care, her choice of providers, birthing choices, etc. Any reasonable person understands the importance of women having these abilities. **But don't Missouri women already have these options?**

The answer is a resounding YES! **Why would we need to amend our constitution, then?**



Taking a closer glance, you may notice the reference is to "persons" and "patient" (seeking or obtaining care).

The "care" being referenced here includes abortion (killing of a preborn child), and reproductive health care (including gender experimentation on anyone - regardless of age). **Neither of these activities have to do with care.**

Remember, this language was constructed by those who have worked tirelessly to usher in a world of gender dissolution and abortion-on-demand-and-without-apology, for years.

What the authors of this legislation *actually intend* is the establishment of abortion and gender destruction as fundamental human rights **guaranteed by the state of Missouri.**

Clearly put, this amends our constitution to:

- Establish what they define as "reproductive health care" to be a fundamental human right
- Invalidate any governmental interference regarding "reproductive care"
- Repeal Missouri's abortion ban
- Repeal the SAFE act
- Require all government entities to treat gender experimentation and destruction of the unborn as a legitimate form of "health care"
- Appear to be "reasonable about allowing regulation" when in fact, ensuring that abortionists will always have the ill-defined "life or health of the mother" card.
- Authorize the creation of bureaucracies to regulate the "Reproductive Freedom" industry
- Create a need to establish civil and criminal penalties for businesses and individuals who have infringed on someone's "Reproductive Freedom"
- Funnel taxpayer dollars to abortion industry giants and their allies
- Redefine forms of child sexual abuse, sex trafficking and abortion trafficking - thereby preventing law enforcement from protecting those victims
- Completely ignore the catastrophic financial costs of destroying our future children, and sexually mutilating the vulnerable
