**THE CASE FOR
EQUAL
PROTECTION
OF THE UNBORN**

EVERY HUMAN BEING IS CREATED IN GOD'S IMAGE FROM CONCEPTION.

Every preborn child, no matter the circumstance, is an image-bearer, fully known and valued by God from the moment of conception.

“So God created man in His own image... male and female He created them” (Genesis 1:27).

“Your eyes saw my unformed substance; in your book were written, every one of them, the days that were formed for me, when as yet there was none of them” (Psalm 129:16).

PERSONHOOD IS A GOD-GIVEN RIGHT, NOT CIRCUMSTANTIAL.

God's value of a life is never conditional: rape, incest, disability, or inconvenience do not disqualify a child from personhood, and no law should say otherwise.

“Before I formed you in the womb I knew you, and before you were born I consecrated you” (Jeremiah 1:5).

“Did not He who made me in the womb make him? And did not one fashion us in the womb?” (Job 31:15).

BIBLICAL JUSTICE DEMANDS PROTECTION FOR THE WEAKEST.

True justice defends the rights of the most vulnerable, including children conceived in rape and incest, and those with disabilities. Every baby deserves the same defense.

“Open your mouth for the mute, for the rights of all who are destitute. Open your mouth, judge righteously, defend the rights of the poor and needy” (Proverbs 31:8-9).

EQUAL PROTECTION REFLECTS THE HISTORIC AND BIBLICAL UNDERSTANDING OF PERSONHOOD.

Early American law and Christian teaching protected preborn children as legal persons.

That is because personhood begins at conception according to Scripture, science, and the human conscience.

SCIENCE AND LAW PROVE EQUAL PROTECTION.

“Rescue those who are being taken away to death; hold back those who are stumbling to the slaughter. If you say, ‘Behold, we did not know this,’ does not He who weighs the heart perceive it? Does not He who keeps watch over your soul know it, and will He not repay man according to His work?” (Proverbs 24:11-12).

“The predominance of human biological research confirms that human life begins at conception, fertilization. At fertilization, the human being emerges as a whole, genetically distinct, individuated zygotic living human organism, a member of the species *Homo sapiens*, needing only the proper environment in order to grow and develop.”
